Marine Safety Act 2010

Section 208(1)

NOTICE OF BOATING ACTIVITY EXCLUSION ZONE

I, Gareth Johnson, Acting Director Maritime Safety (as delegate of the Director, Transport Safety), hereby give notice under section 208(1) of the **Marine Safety Act 2010** that all persons and vessels not registered to take part in the Life Saving Victoria Carnivals 2021 are prohibited from entering and remaining in the following State waters.

Coastal waters adjacent to various Victorian Surf Life Saving Clubs or on coastal beaches, which will be clearly marked by signs and flags on the shore, and in the water by buoys extending up to 400 metres from shore.

The exclusion zone will be in effect for the dates, times, locations and events listed in **Table 1**.
