Flora and Fauna Guarantee Act 1988

NOTICE OF DECISION UNDER SECTION 16

In accordance with section 16G of the Flora and Fauna Guarantee Act 1988, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change, and Mary-Anne Thomas, Minister for Agriculture have:

- (i) considered the recommendation of the Scientific Advisory Committee regarding Ornithorhynchus anatinus (Platypus) as published on the Internet at https://www.environment. vic.gov.au/conserving-threatened-species/threatened-list and in the Government Gazette on 12 November 2020; and
- (ii) considered the recommendation of the Scientific Advisory Committee regarding *Hieraaetus morphnoides* (Little Eagle) as published on the Internet at https://www.environment.vic. gov.au/conserving-threatened-species/threatened-list and in the Government Gazette on 3 December 2020; and
- (iii) decided to recommend to the Governor in Council that the taxa described in Column 1 of Table 1 in the Schedule to this Notice be specified in the Threatened List for the reasons that each taxon meets the criterion and sub-criteria shown in Column 2 of that Table.

SCHEDULE

In Table 1 in this Schedule –

5.1 means **Primary criterion 5.1 of the Flora and Fauna Guarantee Regulations 2020** and that the taxon of flora or fauna is vulnerable.

5.1.1 means **Sub-criterion 5.1.1** of the Flora and Fauna Guarantee Regulations 2020 and that the taxon has undergone, is suspected to have undergone or is likely to undergo in the immediate future a substantial reduction in population size.

5.1.2 means **Sub-criterion 5.1.2 of the Flora and Fauna Guarantee Regulations 2020** and that the taxon's geographic distribution is restricted and at least two of the following circumstances apply –

- (a) the distribution of the population or habitat of the taxon is severely fragmented or restricted to a limited number of threat-based locations;
- (b) there is a continuing decline or reduction in any one of the following
 - (i) extent of occurrence;
 - (ii) area of occupancy;
 - (iii) area, extent or quality of habitat;
 - (iv) number of locations or subpopulations;
- (c) there are extreme fluctuations in any one of the following
 - (i) extent of occurrence;
 - (ii) area of occupancy;
 - (iii) area, extent or quality of habitat;
 - (iv) number of locations or subpopulations;
 - (v) number of mature individuals.
