

Amendment C211moon

Moonee Valley City Council has prepared Amendment C211moon to the Moonee Valley Planning Scheme. The land affected by the Amendment is 81 Charles Street, Ascot Vale. The Amendment proposes to apply the Heritage Overlay (HO529) to 81 Charles Street, Ascot Vale on a permanent basis.

Specifically, Amendment C211moon proposes to:
