Amendment GC182

The Minister for Planning has approved Amendment GC182 to the Casey and Frankston planning schemes.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment facilitates the Western Port Highway Upgrade Project (project) by:

- applying the Specific Controls Overlay to land required for the project and allowing the use and development of that land in accordance with the specific control in the Western Port Highway Upgrade Project Incorporated Document, August 2021.
- amending the Schedule to Clause 72.03 of the Frankston Planning Scheme to insert reference to the new Map No. 6SCO.
- amending the Schedule to Clause 72.04 to list the incorporated document;
- amending the existing PAO1 to make the Head, Transport for Victoria the acquiring authority.

Amendment C247hume

The Minister for Planning has approved Amendment C247hume to the Hume Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment rezones land at 225–285 Donnybrook Road, Mickleham to accommodate the approved re-alignment of Aitken Boulevard. It alters the amount and configuration of Industrial 1 Zone (IN1Z) and General Residential Zone 1 (GRZ1) and introduces a new schedule to the Special Use Zone (SUZ12) to support employment use. It also replaces Schedule 29 of the Development Plan Overlay (DDO29) with a new a Schedule 31 to the Development Plan Overlay (DDO31). The Amendment will also delete Schedule 17 to the Development Plan Overlay (DDO17) which is no longer required.
