Electricity Industry Act 2000

2021 MINISTERIAL ORDER SPECIFYING LICENCE CONDITION

- I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change and Minister responsible for administering the Electricity Industry Act 2000 (the Act), having:
 - a) had regard to:
 - i. costs and benefits, in accordance with section 33AB(2)(a)(i) of the Act; and
 - ii. the written representations of the affected licensee, in accordance with section 33AB(2)(a)(ii) of the Act; and
 - b) consulted with the Premier, the Treasurer and the Minister administering the **Essential Services Commission Act 2001**, in accordance with section 33AD of the Act,

pursuant to sections 33AB and 33AC of the Act, make the following Order.

PRELIMINARY

1. Commencement

This Order commences on the day it is published in the Government Gazette.

2. Definitions and interpretation

In this Order, unless the context otherwise requires:

AusNet means AusNet Electricity Services Pty Ltd, ABN 91 064 651 118; and

Licence means the Electricity Distribution Licence granted by the Commission to AusNet dated 3 June 2015, as amended from time to time.

MINISTERIAL LICENCE CONDITION

3. Specification of Ministerial Licence Condition

The condition in Clause 4 of this Order is specified as a condition of the Licence.

- 4. Ministerial Licence Condition Compliance with the Electricity Distribution Code
 Ministerial Licence Condition:
 - (1) Despite Clause 22.1(b)(1) of this licence:
 - (a) the *Electricity Distribution Code* is taken to omit Clause 6.3.4(d) insofar as that Clause has, or might have, effect for interruptions occurring in the Relevant Period; and
 - (b) the time for payment provided for by Clause 6.4 of the *Electricity Distribution Code*, insofar as that Clause has, or might have, effect for interruptions occurring in the Relevant Period, is amended, and the *Licensee* must make any payments required by clauses 6 and 21.4 of the *Electricity Distribution Code* as soon as reasonably practicable following the commencement of the *2021 Ministerial Order Specifying Licence Condition*.

Notes:

- i. See sections 33AC(1)(c), 33AC(2) and 21(1) of the *Act*.
- ii. The payments that clauses 6 and 21.4 of the *Electricity Distribution Code* provide for, are supply restoration payments and low reliability payments.
- (2) In this condition:
 - (a) **Relevant Period** means the period commencing on 9 June 2021 and ending on 30 June 2021, both days inclusive; and
 - (b) Words and expressions that are defined in the *Electricity Distribution Code* have the same meaning as they have in that Code.

Notes:

 Words and expressions defined in the *Electricity Distribution Code* that are used in this condition are:

interruption;

low reliability payment;

supply;

supply restoration payment.

ii. Words and expressions in this condition that are in bolded italics have the same meaning as they have in this licence: see Clause 1.1 of this licence.

5. Compliance with the Licence as amended by the Ministerial Licence Condition

AusNet must comply with the Licence as amended by the condition specified in Clause 4 of this Order.

Note: See sections 33AI and 33AJ of the Act. Pursuant to section 33AI(1)(a) the condition specified in Clause 4 has effect from the day on which this Order is published in the Government Gazette. Pursuant to section 33AJ, the condition specified in Clause 4 overrides Clause 22.1(b)(1) of the Licence.
