## County Court Act 1958

### AMENDMENT TO A RIGHT TO A PENSION

#### Order in Council

The Governor in Council, under section 14(3A) of the **County Court Act 1958** (the Act), amends the Order in Council made on 4 November 2020, determining that the right of Susan Elizabeth Pullen to a judicial pension shall not be suspended by reason of operation of section 14(3A)(b)(i) of that Act with respect to Ms Pullen holding an office or place of profit under the Crown while appointed as a member and deputy chairperson of the Adult Parole Board (the Board), to provide that Ms Pullen's pension shall not be suspended whilst appointed as a member, deputy chairperson, or acting chairperson of the Board.

### AMENDMENT TO A RIGHT TO A PENSION

#### Order in Council

The Governor in Council, under section 35(2) of the **Public Prosecutions Act 1994** and section 14(3A) of the **County Court Act 1958** (the Act), amends the Order in Council made on 30 March 2021, determining that the right of Peter Norman Rose QC to a pension shall not be suspended by reason of the operation of section 14(3A)(b)(i) of the Act while he holds any office or place of profit while appointed as a member of the Adult Parole Board (the Board), to provide that Mr Rose's pension shall not be suspended whilst appointed as a member, deputy chairperson, and for any periods that he is required to act as chairperson of the Board.
