ORDER TO VARY DETERMINATION OF THE PORT PHILLIP AND WESTERNPORT CATCHMENT AND LAND PROTECTION REGION

Order in Council

The Governor in Council under section 10(1)(a) of the **Catchment and Land Protection Act 1994** and pursuant to section 27 of the **Interpretation of Legislation Act 1984**, varies the Order in Council made on 29 October 2002 under section 10(1) of the **Catchment and Land Protection Act 1994** and entitled 'Abolition of the Port Phillip Catchment and Land Protection Region and Determination of the Port Phillip and Westernport Catchment and Land Protection region and the Definition of its Boundaries' which determined the Port Phillip and Westernport Catchment and Land Protection Region, attached as Schedule A to this Order, to substitute for the words 'Port Phillip and Westernport Catchment and Land Protection Region', the words 'Port Phillip and Westernport Region', wherever occurring.

**ABOLITION OF THE PORT PHILLIP CATCHMENT AND LAND PROTECTION REGION
AND DETERMINATION OF THE PORT PHILLIP AND WESTERNPORT CATCHMENT AND
LAND PROTECTION REGION AND THE DEFINITION OF ITS BOUNDARIES**

Order in Council

The Governor in Council, under Section 10(1) of the **Catchment and Land Protection Act 1994** and on the recommendation of the Minister for Environment and Conservation:

1. abolishes the catchment and land protection region known as Port Phillip Catchment and Land Protection Region determined by Order of the Governor-in-Council dated 29 November 1994 and published in the Government Gazette on 1 December 1994;
2. determines that the area within Victoria delineated in heavy black on plan numbered S-1525/1 contained in the Schedule to this Order, the original of which is held at Head Office of the Department of Natural Resources and Environment, and a true copy of which is held at the Central Plan Office, is a catchment and land protection region to be known as the Port Phillip and Westernport Catchment and Land Protection Region, and
3. defines the boundaries of the Port Phillip and Westernport Catchment and Land Protection Region, as follows:
 - (i) by heavy black delineation on Plan S-1525/1; and
 - (ii) where any boundary is formed by a roadway reserve, the boundary is situated in the centre of the road for the time being on that roadway reserve.

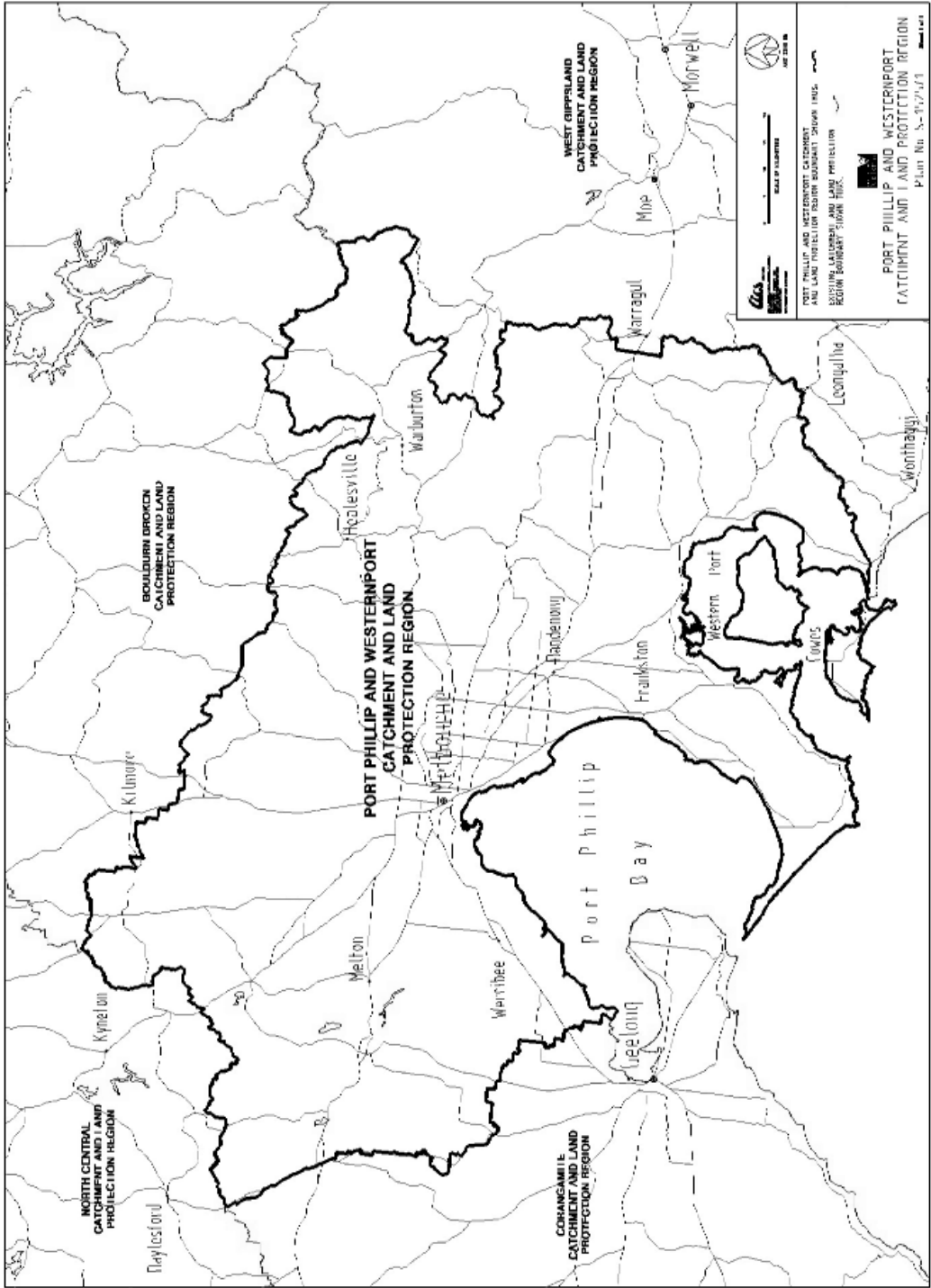
