Section 184

WATERWAY RULE

I, Shaun Rodenburg, Director Maritime Safety (as delegate of the Director, Transport Safety) make the following waterway rule under section 184 of the **Marine Safety Act 2010**.

SCHEDULE 104: The Local Port of Gippsland Lakes

Waterway Manager: Gippsland Ports Committee of Management Inc.

After Clause 104.2(m)(ii) and before Clause 104.2(n) insert:

(iii) for powered vessels of eight (8) metres in length or greater for the waters of Bancroft Bay situated between a line from a 5-knot sign⁷⁹ on Shaving Point south-easterly to a 5-knot sign⁸⁰ on the opposite shore and marked mid-way by a 5-knot buoy⁸¹, and a line from a 5-knot sign⁸² on Bell's Point south-westerly to a 5-knot sign⁸³ on the opposite shore and marked by 5-knot buoys ^{84,85}.
