Road Management Act 2004

DESIGNATION OF TOW AWAY AREA UNDER SCHEDULE 4 CLAUSE 5 FOR TOW AWAY AREA FOR 2021 NEW YEAR'S EVE CELEBRATIONS IN MELBOURNE

Clause 5 of Schedule 4 to the **Road Management Act 2004** provides that a State road authority may move, keep or impound any vehicle that is unlawfully parked or left standing in an area designated by the Minister, (referred to in this instrument as a 'tow-away area'), and may charge the owner of the vehicle a reasonable fee.

For the purposes of that provision, I, Angela Grice, Executive Director Planned Disruptions at the Department of Transport and delegate of the Minister for Roads, designate the locations specified and shown on the attached plan, to be a tow-away area to facilitate the 2021 New Year's Eve Celebrations, to be held in and around Melbourne.

This instrument takes effect:

7.00 am on Monday 27 December 2021 and expires at 2.00 pm on Saturday 1 January 2022

- Little Bourke Street between Spring Street and Exhibition Street
- Flinders Lane between Exhibition Street and Swanston Street
- Little Collins Street between Spring Street and Exhibition Street

7.00 am on Friday 31 December 2021 and expires at 3.00 am on Saturday 1 January 2022

- Boathouse Drive
- Alexandra Avenue between Princes Bridge and Swan Street Bridge
- Batman Avenue between Flinders Street and Swan Street
- Lansdowne Street between Wellington Parade and Treasury Place

7.00 am on Thursday 30 December 2021 and expires at 3.00 am on Saturday 1 January 2022

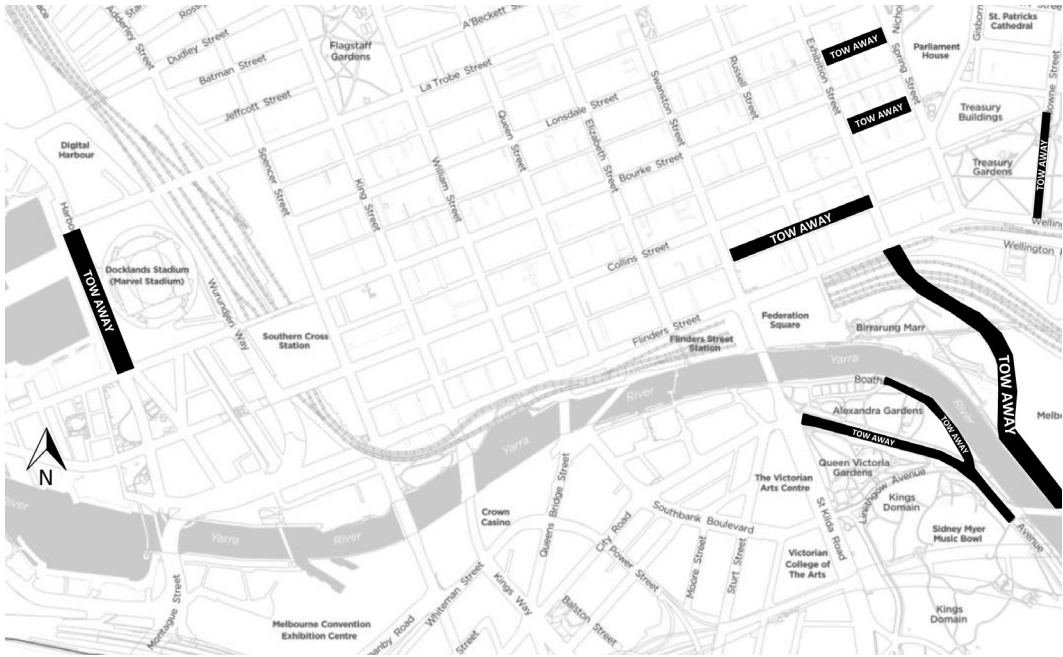
- Harbour Esplanade, both sides, between La Trobe Street and Bourke Street.
