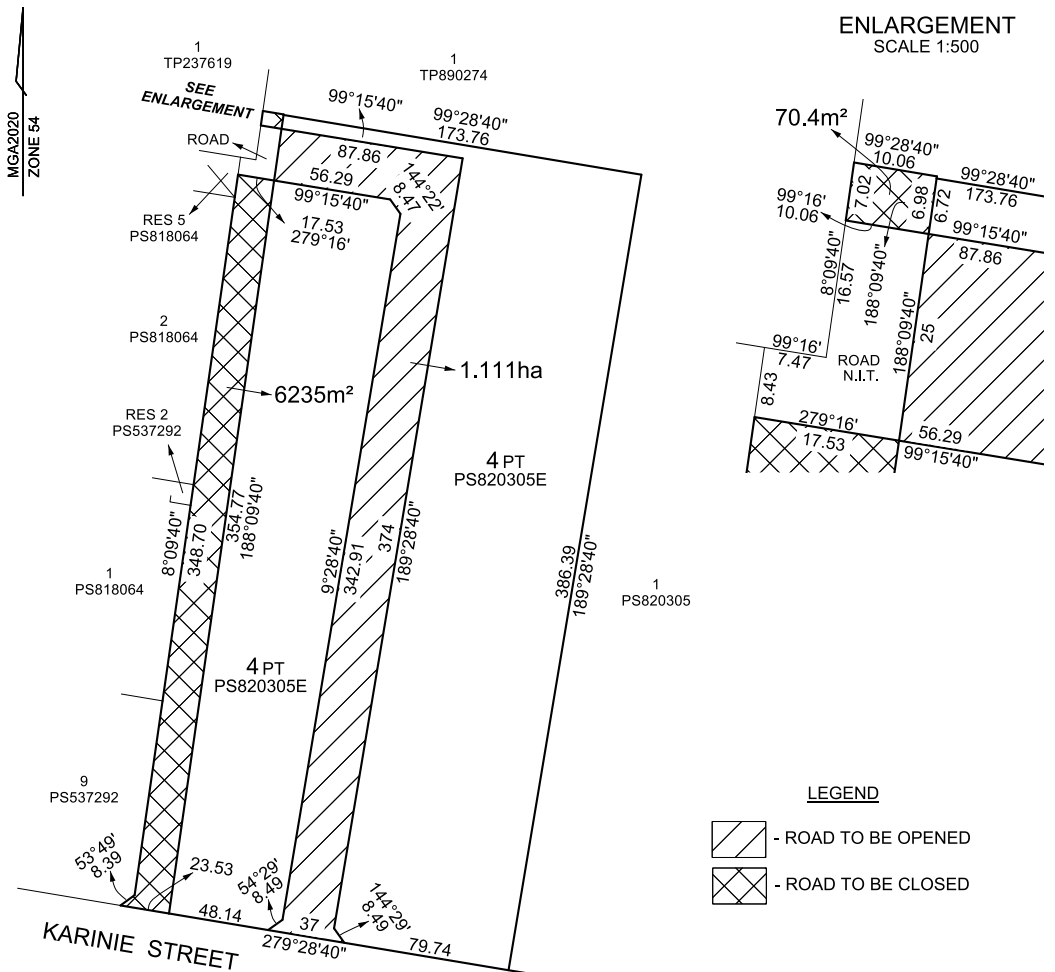


ROAD DEVIATION AND LAND EXCHANGE

ORDERS IN COUNCIL**Agricultural and Veterinary Chemicals (Control of Use) Act 1992****ORDER REGULATING AERIAL SPRAYING FROM REMOTELY PILOTED AIRCRAFT**

Order in Council

The Governor in Council under section 25A(2) of the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992** makes the following Order.

1 Purpose

The purpose of this Order is to regulate aerial spraying from remotely piloted aircraft.

2 Commencement

This Order takes effect on the day of its publication in the Government Gazette.

3 Definitions

In this Order –

Agricultural chemical product has the same meaning as in the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**

Aerial spraying has the same meaning as in the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**;

Approved label has the same meaning as in the Agvet Code of Victoria;

Agvet Code of Victoria has the same meaning as in the **Agricultural and Veterinary Chemicals (Victoria) Act 1994**;

Concentrate application technique means the application of an undiluted agricultural chemical product by aerial spraying.

Permit means a permit issued under Part 7 of the Schedule to the Agvet Code of Victoria.

Spot spraying means a spray applied to small, restricted areas such as individual weeds or small patches of weeds and plants.

Ultra-low volume application technique means an aerial spraying technique that utilises equipment delivering volumes below 3 litres per hectare that produces a droplet size spectrum that is classified as very fine or smaller under ANSI/ASAE S572.1, Spray Nozzle Classification by Droplet Spectra: American Society of Agricultural and Biological Engineers, as published from time to time.

4 Regulation of aerial spraying from remotely piloted aircraft

Aerial spraying from remotely piloted aircraft must:

- (a) not be conducted before sunrise or after sunset; and
- (b) only be conducted if the approved label of the agricultural chemical product or permit specifies the use to be undertaken by aerial spraying or spot spraying, and instructions for aerial spraying or spot spraying in relation to that use are complied with, including any water rates; and

Note: Spot spraying instructions are alternatively described as ‘high volume spraying’ and can be accompanied by instructions for application by ‘knapsack’ or ‘handgun’.

- (c) not be conducted using ultra-low volume application technique or concentrate application technique unless the approved label for the agricultural chemical product or permit provides directions for the use of these techniques by aerial spraying; and
- (d) be undertaken in accordance with the wind speed parameters specified on the approved label of the agricultural chemical product or permit. If the approved label of the agricultural chemical product or permit does not specify wind speed parameters, aerial spraying must only be conducted when the wind speed is greater than 3 km/hr and less than 13 km/hr at the time and place of application.

5 Notice of incorporation

The definition of **ultra-low volume application technique** incorporates material entitled ‘ANSI/ASAE S572.1, Spray Nozzle Classification by Droplet Spectra: American Society of Agricultural and Biological Engineers’ pursuant to section 77(2) of the **Agricultural and Veterinary Chemicals (Control of Use) Act 1992**.
