10/2021	(1)	This Part, section 4(2), Divisions 4, 6, 7 and 8 of Part 2 and Part 3 come into operation on the day after the day on which this Act receives the Royal Assent.		
	(2)	Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.		
	(3)	If a provision of this Act does not come into operation before the first anniversary of the day on which this Act receives the Royal Assent, it comes into operation on that day.		
11/2021	(1)	This Part, Part 19, Division 2 of Part 20 and Part 24 come into operation on the day after the day on which this Act receives the Royal Assent.		
	(2)	The remaining provisions of this Act, except Part 22, come into operation on 26 April 2021.		
	(3)	Subject to subsection (4), Part 22 comes into operation on a day or days to be proclaimed.		
	(4)	If a provision referred to in subsection (3) does not come into operation before 23 February 2022, it comes into operation on that day.		
12/2021	(1)	This Part and Parts 4, 5 and 6 come into operation on the day after the day on which this Act receives the Royal Assent.		
	(2)	Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.		
	(3)	If a provision referred to in subsection (2) does not come into operation before 1 February 2022, it comes into operation on that day.
