Transport (Compliance and Miscellaneous) Act 1983

AMENDING CONDITIONS NO. 2/2021 MADE UNDER SECTION 220D

The Head, Transport for Victoria, the entity established under section 64A of the **Transport Integration Act 2010**, under section 220D(1) of the **Transport (Compliance and Miscellaneous) Act 1983**, hereby determines the following conditions (the **Amending Conditions No.2/2021**) which amend the Conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** dated 22 December 2020, published in the Victoria Government Gazette No. S 692 dated Wednesday 23 December 2020, effective 1 January 2021, as amended previously by amending conditions published in the Victoria Government Gazette on Tuesday 2 March 2021 (No. S 98).

The Amending Conditions No. 2/2021 take effect from and including the day they are published in the Government Gazette.

AMENDING CONDITIONS NO. 2/2021

The conditions under section 220D of the **Transport (Compliance and Miscellaneous) Act 1983** dated 22 December 2020, published in the Victoria Government Gazette No. S 692 dated Wednesday 23 December 2020, effective 1 January 2021, as amended previously by amending conditions published in the Victoria Government Gazette on Tuesday 2 March 2021 (No. S 98), are amended as follows:

1. In the paragraph immediately before the heading to Chapter 1B, for ‘Chapters 1B and 1D’ **substitute** ‘Chapters 1A and 1B’.
2. For the heading to Chapter 1B, **substitute** ‘**Chapter 1A: Replacements, Refunds and Reimbursements**’.
3. For the heading to Chapter 1D, **substitute** ‘**Chapter 1B: Off-peak myki money fares for travel in zone 1 only or zones 1 + 2 from 31 January 2021 to 2 July 2021**’
4. In Chapter 1D –
 - (a) for the first two paragraphs –

‘The Conditions in this Chapter apply from 31 January 2021 until 30 April 2021 (inclusive).

The myki Money fare amounts specified in Table 1 in this Chapter apply for journeys in zone 1, zone 2 and zones 1 + 2 from 31 January 2021 until 30 April 2021 (inclusive)’ – **substitute** –

‘The Conditions in this Chapter apply from 31 January 2021 until 2 July 2021 (inclusive).

The myki Money fare amounts specified in Table 1 in this Chapter apply for journeys in zone 1, zone 2 and zones 1 + 2 from 31 January 2021 until 2 July 2021 (inclusive).’; and
 - (b) for the heading to Table 1, **substitute** ‘**Table 1 – myki Money fares – 31 January 2021 – 2 July 2021**’
5. In Chapter 4, under the heading ‘Calculating myki Money Fares’ –
 - (a) under the subheading ‘**myki Money fare amounts**’ –
 - (i) in the first paragraph, for ‘Chapter 1D’ **substitute** ‘Chapter 1B’; and
 - (ii) for the third paragraph –

‘From 31 January to 30 April 2021, different myki Money fare amounts apply for travel in zone 1 only or zones 1 + 2, as specified in Chapter 1D’ – **substitute** –

‘From 31 January to 2 July 2021, different myki Money fare amounts apply for travel in zone 1 only or zones 1 + 2, as specified in Chapter 1B.’
 - (b) under the subheading ‘**Fare calculation – Daily fare cap**’, for the third paragraph –

‘Daily cap fare amounts are specified in Table A in Schedule 1 of these Conditions (except from 31 January to 30 April 2021, see Table 1 in Chapter 1D).’ – **substitute** –

‘Daily cap fare amounts are specified in Table A in Schedule 1 of these Conditions (except from 31 January to 2 July 2021, see Table 1 in Chapter 1B).’
 - (c) under the subheadings ‘**Fare calculation – discounts and free travel**’ and ‘**Off-peak discounts**’, for the first paragraph –

‘Note: Further to the below discounts, from 31 January to 30 April 2021, off-peak myki Money discounts apply to travel in zone 1 only or zones 1 + 2, as specified in Chapter 1D.’ – **substitute** –

‘Note: Further to the below discounts, from 31 January to 2 July 2021, off-peak myki Money discounts apply to travel in zone 1 only or zones 1 + 2, as specified in Chapter 1B.’

6. In Schedule 1 to the Conditions (**‘SCHEDULE 1: FARES’**), for the paragraph immediately under the heading ‘Part 1: myki fares’ –

‘NOTE: BETWEEN 31 JANUARY AND 30 APRIL 2021, FARES SET OUT IN TABLE A AND ROW 1 OF TABLE D DO NOT APPLY AND ARE REPLACED DURING THAT PERIOD BY FARES SPECIFIED IN CHAPTER 1D.’ –

substitute –

‘NOTE: BETWEEN 31 JANUARY AND 2 JULY 2021, FARES SET OUT IN TABLE A AND ROW 1 OF TABLE D DO NOT APPLY AND ARE REPLACED DURING THAT PERIOD BY FARES SPECIFIED IN CHAPTER 1B.’

The amendments made by these amending conditions apply in respect of entitlements to use a public transport service that are subject to the conditions contained in the Conditions and that are able to be exercised on or after the commencement of these amending conditions, including entitlements that existed, but had not been exercised, before these amending conditions were published in the Government Gazette.
