1 Objectives

The objective of these Regulations is to amend the expiry date of the Crown Land (Reserves) (Outdoor Dining) Regulations 2020.

2 Authorising provision

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

3 Commencement

These Regulations come into operation on the day on which they are published in the Government Gazette.

4 Principal Regulations

In these Regulations, the Crown Land (Reserves) (Outdoor Dining) Regulations 2020 which were published in Special Government Gazette No. S 508 on 8 October 2020, are called the Principal Regulations.

5 Extension of expiry date

For regulation 4 of the Principal Regulations substitute – 'These Regulations expire on 16 December 2021.'
