Notice of Acquisition

Compulsory Acquisition of Interest in Land


The Secretary to the Department of Transport (Authority), being the project authority for the Robinsons Road, Deer Park Level Crossing Removal Project to which the **Major Transport Projects Facilitation Act 2009** applies, declares that, by this notice, it acquires the following interests subsisting in the land described as parcel 4 on SP24345 on the attached plan, being part of the land contained in Certificate of Title Volume 11323 Folio 297:

The interest in fee simple of the registered proprietor Pincove Pty Ltd ACN 121 786 221, the interests of Powercor Australia Ltd, and any other interests subsisting in the land, except for the leasehold interest of Fulton Hogan Constructions Pty Ltd and the rights that any dominant tenement owners enjoy to use the carriageway easements marked E-2 and E-7 on Plan of Subdivision PS 638828K.

The interests in the land are acquired by the Authority freed and discharged from any right, title, power, authority or interest of Powercor Australia Ltd, including the power supply (overhead) easement marked 'E-6 and E-7' on Plan of Subdivision PS 638828K registered at the Land Titles Office in dealing number AN577888S.

The Secretary to the Department of Transport further declares, for the purposes of section 114(b) of the **Major Transport Project Facilitation Act 2009**, that the Secretary is acquiring the interest in fee simple in the land described in this notice (which interest it takes subject to the leasehold interest and the rights to enjoy the use of the carriageway easements E-2 and E-7 identified above).

Despite the general description above, this Notice does not apply to any part of parcel 4 on SP24345 on the attached plan that is land in, under or forming part of the road known as the Robinsons Road Service Road, being a municipal road registered on Melton City Council's register of public roads (asset identification number 106726).
