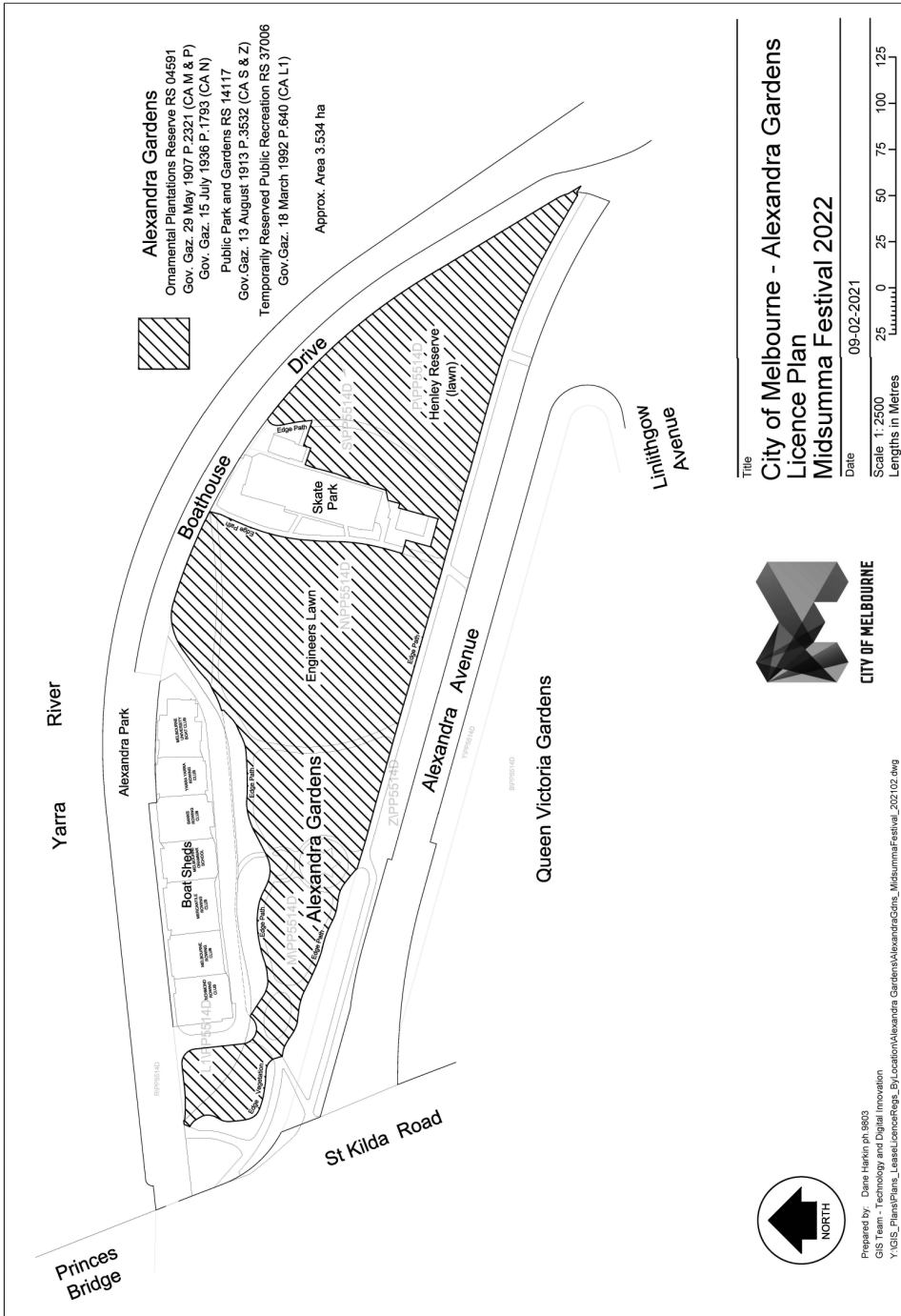

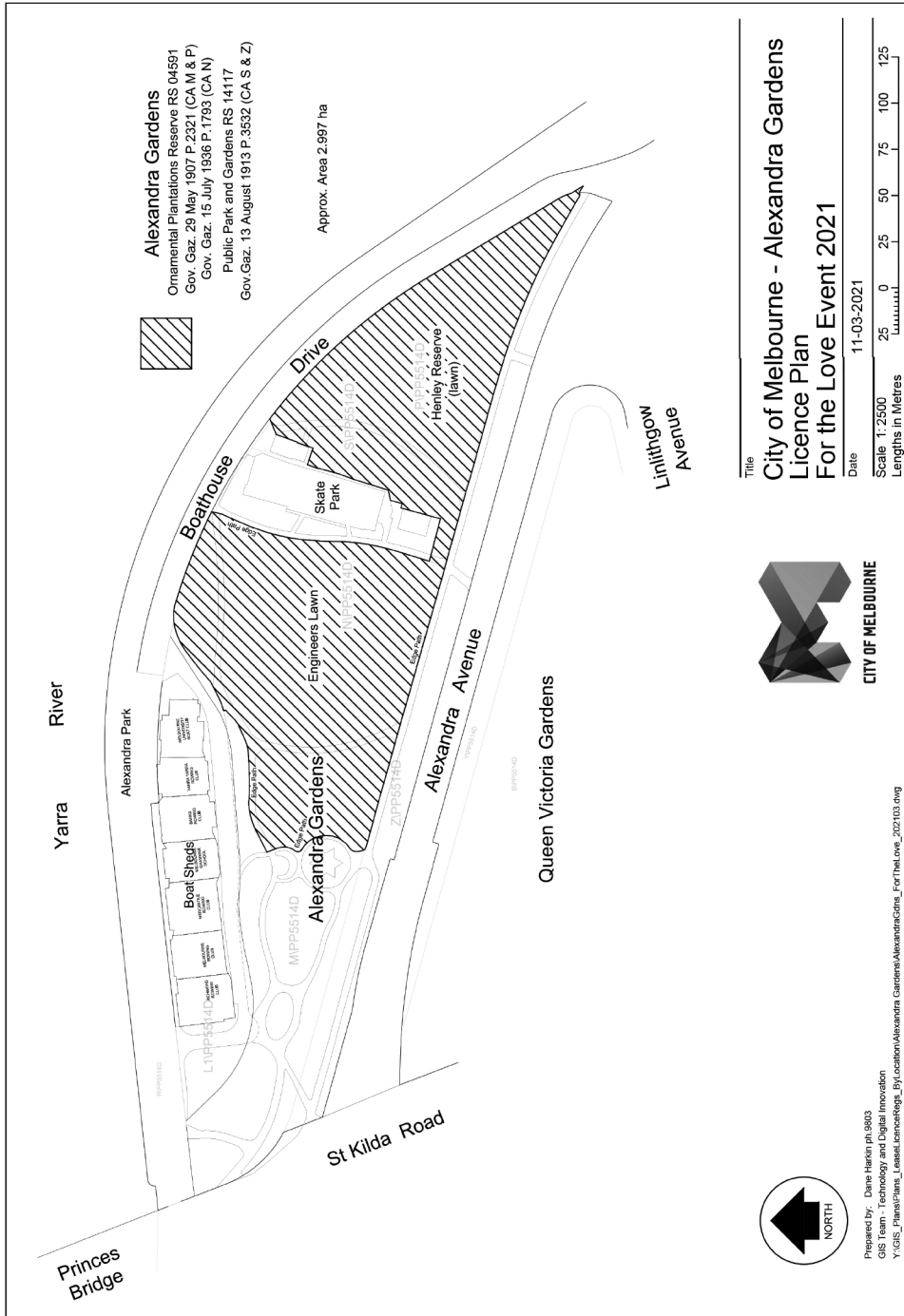

## Land Acquisition and Compensation Regulations 2021

I, Jaclyn Symes MP, Attorney-General and Minister responsible for the **Land Acquisition and Compensation Act 1986** (the Act), give notice under section 12 of the **Subordinate Legislation Act 1994** that further to public consultation on a regulatory impact statement (RIS), I have decided to recommend the making of the Land Acquisition and Compensation Regulations 2021 (the proposed Regulations). These will replace the Land Acquisition and Compensation Regulations 2010.

The objective of these Regulations is to prescribe forms, fees and other matters for the purposes of the **Land Acquisition and Compensation Act 1986**. These support the objectives of the Act to provide a system for acquisition of land by public authorities that is efficient, certain and equitable.

An exposure draft of the proposed Regulations and the RIS were released for public consultation on the Engage Victoria website between 14 January 2021 and 12 February 2021. Comments and submissions were received from five sources and have been considered in accordance with section 11 of the **Subordinate Legislation Act 1994**.

In response to feedback in the comments and submissions to the RIS, I intend that the proposed Regulations will include changes to the exposure draft to:

- prescribe additional forms for an Authority to state that it does not intend to acquire the interest by compulsory process (served pursuant to section 7(1)(b)(i)), a notice of intention to enter land (served pursuant to section 74(2)(a)), and a notice of intention to enter upon land and occupy the land (served pursuant to section 75(3)).
- make minor and technical amendments for drafting consistency and clarity.
