## Electricity Industry Act 2000

### MINISTERIAL ORDER UNDER SECTION 35(3B)

I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change and Minister responsible for administering the **Electricity Industry Act 2000** (the Act), specify pursuant to sections 35(3B)(a) and 35(3B)(b) of the Act, the following date on which a licensee may publish a notice under section 35(3) of the Act, and the following date on which tariffs varied in accordance with section 35(3) of the Act must take effect and revoke a previous Order made under section 35(3B) of the Act.

**1. Commencement**

This Order commences on the date that it is published in the Government Gazette.

**2. Order to be read in conjunction with Order made under section 13 the Act**

This Order is to be read in conjunction with obligations established by the Order made under section 13 of the Act and published in the Gazette on 30 May 2019 (no. S 208).

**3. Date on which a notice varying licensee standing offers may be published**

Pursuant to section 35(3B)(a) of the Act, if a licensee proposes to publish a notice under section 35(3) of the Act, varying the tariffs determined by the licensee and published in the Government Gazette under section 35(1) of the Act, the notice may be published on 19 July 2021.

**4. Date on which a variation to a licensee standing offer in accordance with Clause 3 must take effect**

Pursuant to section 35(3B)(b) of the Act, any variation to licensee standing offer tariffs in accordance with Clause 3 of this Order must take effect on 1 August 2021.

**5. Revocation of previous Order**

The Ministerial Order made under section 35(3B) of the Act dated 25 November 2020 and published in the Government Gazette on Thursday 26 November 2020 (no. S 612) is revoked.

**6. Expiry of this Order**

This Order expires on 31 August 2021.

I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change and Minister responsible for administering the **Gas Industry Act 2001** (the Act), specify pursuant to sections 42(3B)(a) and 42(3B)(b) of the Act, the following date on which a licensee may publish a notice under section 42(3) of the Act, and the following date on which tariffs varied in accordance with section 42(3) of the Act must take effect and revoke a previous Order made under section 42(3B) of the Act.

**1. Commencement**

This Order commences on the date that it is published in the Government Gazette.

**2. Date on which a notice varying licensee standing offers may be published**

Pursuant to section 42(3B)(a) of the Act, if a licensee proposes to publish a notice under section 42(3) of the Act, varying the tariffs determined by the licensee and published in the Government Gazette under section 42(1) of the Act, the notice may be published on 19 July 2021.

**3. Date on which a variation to a licensee standing offer under Clause 2 must take effect**

Pursuant to section 42(3B)(b) of the Act, any variation to licensee standing offer tariffs in accordance with Clause 2 of this Order must take effect on 1 August 2021.

**4. Revocation of previous Order**

The Ministerial Order made under section 42(3B) of the Act dated 25 November 2020 and published in the Government Gazette on Thursday 26 November 2020 (no. S 612) is revoked.

**5. Expiry of this Order**

This Order expires on 31 August 2021.
