(2)	If a provision of this Act does not come into operation before 1 May 2022, it comes into operation on that day.		
(1)	Subject to subsection (2), this Act comes into operation on a day or days to be proclaimed.		
(2)	If a provision of this Act does not come into operation before 30 September 2021, it comes into operation on that day.		
(1)	This Part and Part 4, sections 22A, 32, 38 and 39, 62 and 63, 67 and 69, Part 6, Divisions 4 and 7 of Part 8, section 94 and Part 9 come into operation on the day after the day on which this Act receives the Royal Assent.		
(2)	Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.		
(3)	If a provision referred to in subsection (2) does not come into operation before 1 March 2022, it comes into operation on that day.		
(1)	This Part and Part 4 come into operation on the day after the day on which this Act receives the Royal Assent.		
(2)	Subject to subsection (3), the remaining provisions of this Act come into operation on a day or days to be proclaimed.		
(3)	If a provision referred to in subsection (2) does not come into operation before 1 January 2022, it comes into operation on that day.
