ROAD DECLARATION

Head, Transport for Victoria, pursuant to section 14 of the **Road Management Act 2004**, upon publication of this notice, revokes and declares the road described in the Schedule and on the plans attached.

The effects of these Road Declarations on road names are described in Table 1.

SCHEDULE

ARTERIAL ROAD

- a) That part of Sturt Street identified by cross hatching on the plan numbered GP24536 is revoked as described in the legend in the said plan.

MUNICIPAL ROAD

- b) That part of Sturt Street identified by cross hatching on the plan numbered GP24536A is declared as described in the legend in the said plan.
