Project Development and Construction Management Act 1994

NOMINATION ORDER

Order in Council

The Governor in Council with the advice of the Executive Council under section 6 of the **Project Development and Construction Management Act 1994** ('the Act') and on the recommendation of the Premier, by Order declares the redevelopment of 1–12 Bills Street, Hawthorn ('Bills Street Redevelopment') including the design, construction, financing, maintenance and operation of and all ancillary and incidental activities associated with the Bills Street Redevelopment to be a project to which the Act applies ('Nominated Project') and, in accordance with section 7 of the Act, specifies that:

- (a) the Minister for Housing is the Minister who is to be responsible for the Nominated Project; and
- (b) the Director of Housing, being a body corporate established under section 9 of the **Housing Act 1983**, is to be the facilitating agency for the Nominated Project.

This Order comes into effect on the date it is published in the Government Gazette.

The Governor in Council with the advice of the Executive Council under section 8 of the **Project Development and Construction Management Act 1994** ('the Act') and on the recommendation of the Premier, by Order specifies, in respect of the redevelopment of 1–12 Bills Street, Hawthorn ('Bills Street Redevelopment') including the design, construction, financing, maintenance and operation of and all ancillary and incidental activities associated with the Bills Street Redevelopment, a nominated project under section 6 of the Act ('Nominated Project'), that:

- (a) the following provisions of Part 3 of the Act are to apply in relation to the Nominated Project: sections 14, 17, 18, 19, 20, 20A to 20J, 21, 22, 23, 24, 25 and 26;
- (b) the following provisions of Part 3 of the Act are to apply in relation to the Director of Housing, being a body corporate established under section 9 of the **Housing Act 1983** which is the facilitating agency for the Nominated Project: sections 14, 17, 18, 19, 20, 20A to 20J, 21, 22, 23, 24, 25 and 26;
- (c) the following provisions of Part 3 of the Act are to apply in relation to the Minister for Housing, the responsible Minister for the Nominated Project: sections 19, 20, 22, 23 and 24.

This Order comes into effect on the date it is published in the Government Gazette.
