Crown Land (Reserves) Act 1978

CROWN LAND (RESERVES) (YARRA PARK) FURTHER AMENDMENT REGULATIONS 2021

I, Lily D'Ambrosio, Minister for Energy, Environment and Climate Change, make the following Regulations.

1 Objectives

The objective of these Regulations is to amend the Crown Land (Reserves) (Yarra Park) Regulations 2010 –

- (a) to amend the expiry date of those Regulations; and
- (b) to amend the fee setting powers of the committee.

2 Authorising provision

These Regulations are made under section 13 of the **Crown Land (Reserves) Act 1978**.

3 Commencement

These Regulations come into operation on the day on which they are published in the Government Gazette.

4 Principal Regulations

In these Regulations, the Crown Land (Reserves) (Yarra Park) Regulations 2010 which were published in Special Government Gazette No. S 88 on 15 March 2010, and subsequently amended by the Crown Land (Reserves) (Yarra Park) Amendment Regulations 2011 published in Government Gazette No. G 21 on 26 May 2011, page 1148, the Crown Land (Reserves) (Yarra Park) Amendment Regulations 2020 published in Special Government Gazette No. S 126 on 12 March 2020, the Crown Land (Reserves) (Yarra Park) Amendment Regulations 2021 published in Special Government Gazette No. S 117 on 12 March 2021, are called the Principal Regulations.

5 Extension of expiry date

For regulation 4 of the Principal Regulations **substitute** –
'These Regulations expire on 30 June 2023.'

6 Revocation of regulations 11(2) and 11(3)

Regulations 11(2) and 11(3) of the Principal Regulations are revoked.

7 Substitution of regulation 19(4)

For regulation 19(4) of the Principal Regulations **substitute** –

- '(4) The Committee may impose a fee for a permit to use an improvement, service or facility in the Park to undertake an activity specified paragraph (1)(a), (1)(b), (1)(c), 1(d), 1(e) or (1)(f).'

8 Substitution of regulation 34(4)

For regulation 34(4) of the Principal Regulations **substitute** –

- '(4) An improvement, service or facility must not be used for an organised event unless the relevant fee, if any, imposed by the Committee, has been paid.'

9 Revocation of Schedule and Plan

The Schedule and Plan to the Principal Regulations are **revoked**.
