Notice of Approval of Amendment

Amendment C201dare

The Minister for Planning has approved Amendment C201dare to the Darebin Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment facilitates the use and development of land at 906 Plenty Road, Bundoora, for a major sports and recreation facility, indoor recreation facility and open sports ground, the removal of vegetation and native vegetation, the erection of signage, the creation or alteration of access to a road in a Road Zone Category 1, and associated buildings and work by applying a Specific Controls Overlay (SCO5) to the site, introducing an Incorporated Document 'La Trobe Sports Park Stage 3 – September 2021' in the Darebin Planning Scheme, amending the Schedules to Clauses 45.12, 72.03 and 72.04 in the Darebin Planning Scheme, and making associated changes, including to mapping.
