#### **Education and Training Reform Act 2006**

MINISTERIAL ORDER NO. 1337

Order Amending Ministerial Order No. 615 – Amendment to Order Fixing of Fees Administered by the Victorian Registration and Qualifications Authority

The Minister for Education and the Minister for Training and Skills make the following Order -

#### 1. Title

This Order may be cited as Ministerial Order No. 1337 – Order Amending Ministerial Order No. 615 – Amendment to Order Fixing of Fees Administered by the Victorian Registration and Qualifications Authority.

#### 2. Purpose

To respond to certain disruptions caused by the human biosecurity emergency known as coronavirus (COVID-19), this Order amends Ministerial Order No. 615 – Fixing of Fees Administered by the Victorian Registration and Qualifications Authority (Ministerial Order 615) to fix certain fees as nil.

#### 3. Authorising Provisions

This Order is made under sections 4.3.10(3), 4.3.16(3)(bc), 5.2.13, 5.10.4 and clause 3 of Schedule 6 to the Education and Training Reform Act 2006.

#### 4. Commencement

This Order takes effect on the date it is signed.

## 5. Amendment to Order Fixing Fees Administered by the Victorian Registration and Qualifications Authority

- (1) Clause E of Schedule 1 to Ministerial Order 615 is **revoked**.
- (2) After clause D of Schedule 1 to Ministerial Order 615, insert
  - <sup>•</sup>EA. (1) Notwithstanding clauses A, B, C and D, during the emergency period, the following fee fixed under this Schedule is nil
    - (a) The fee fixed for applications for re-registration to award, confer or issue a registered senior secondary qualification (under section 4.3.10(3) of the Education and Training Reform Act 2006).
    - (2) In this clause, **emergency period** means the period commencing on the day on which this clause commences and ending
      - (a) 31 December 2021; or
      - (b) a later date fixed by the Secretary of the Department of Education and Training.'.
- (3) Clause E of Schedule 2 to Ministerial Order 615 is revoked.
- (4) After clause D of Schedule 2 to Ministerial Order 615, insert
  - <sup>•</sup>EA. (1) Notwithstanding clauses A, B, C and D, during the emergency period, the following fees fixed under this Schedule are nil
    - (a) The fee fixed for applications for re-registration to provide and or award, confer or issue a vocational education and training qualification, course or subject or unit of competency or module and or a further education course (under section 4.3.16(3)(bc) of the **Education and Training Reform Act 2006**);

### SPECIAL

- (b) The fee fixed for annual instalments for an ACFE Board registered organisation and all other registered education and training organisations.
- (2) Subclause (1) does not apply to the following education and training organisations registered under 4.3 of the Education and Training Reform Act 2006
  - (a) A school or a principal of a school; or
  - (b) A public sector body within the meaning of the **Public** Administration Act 2004.
- (3) In this clause, **emergency period** means the period commencing on the day on which this clause commences and ending
  - (a) 31 December 2021; or
  - (b) a later date fixed by the Secretary of the Department of Education and Training.'.
