##### Amendment C246hume

The Minister for Planning has approved Amendment C246hume to the Hume Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Victoria Government Gazette.

The Amendment changes the Hume Planning Scheme to facilitate development of land within Craigieburn West in accordance with the vision for urban growth outlined in the Craigieburn West Precinct Structure Plan (PSP) by rezoning land to Schedule 12 to the Urban Growth Zone. It also makes a number of other consequential changes to the Hume Planning Scheme to support the implementation of the Craigieburn West PSP.
