#### Notice of Approval of Amendment

##### Amendment L13

The Minister for Planning and Local Government has approved Amendment L13 to the Bayside Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment inserts a site specific clause that requires a planning permit to be obtained prior to the demolition of certain buildings that are included in a schedule to the control. The clause will remain in force until 30 December 1998.

### **REVOCATION OF PART OF**

#### **RESERVATION IN EXTENSION PROJECT AREA**

The Governor in Council, on the recommendation of the Minister for Planning and Local Government (being the Minister administering the **Melbourne City Link Act 1995**), under section 93C(2) of the **Melbourne City Link Act 1995** revokes:-

(a) the Order in Council of 9 June 1873 (vide Government Gazette 1873 p. 1058) permanently reserving from sale land in Melbourne as a Site for Flinders Park; and

(b) the Crown Grant Volume 600 Folio 903 - insofar as the Order and the Crown Grant relate to the area of 7216m<sup>2</sup> shown diagonally hatched on the plan numbered LEGL./98-17 lodged in the Central Plan Office.
