



- Link-Up Victoria assists with tracing and reunions of Aboriginal and Torres Strait Islander peoples directly affected by Government policies of forced removal of children from their family homes.
- Link-Up currently employ 2 females but are repeatedly receiving requests from male clients and community members for a male worker that they can relate to.
- Whether in an Aboriginal Traditional or urban environment, there is a trend for men

and women's business to be dealt with separately in accordance with Aboriginal cultural values, customs and expectations.

 Many male clients, particularly the elderly, do not feel comfortable speaking with a female worker. They feel embarrassed and ashamed to discuss issues of separation and abuse and prefer a male worker.

The Tribunal grants an exemption from the operation of Sections 13, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to advertise for a male Aboriginal worker.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 6 October 2002.

EXEMPTION

Application No. 54 of 1999

The Victorian Civil and Administrative Tribunal has considered an application pursuant to Section 83 of the **Equal Opportunity Act 1995** by Westgate Sports and Leisure Complex. The application for exemption is to enable the applicant to open an exclusive ladies only area in the leisure centre's gymnasium and have it staffed by female personnel.

Upon reading the material tendered in support of this application the Tribunal is satisfied that it is appropriate to grant an exemption from Sections 13, 42, 65, 100 and 195 of the Act to open an exclusive ladies only area in the leisure centre's gymnasium and have it staffed by female personnel.

In granting this exemption the Tribunal noted:

- The applicant is a multi purpose sporting facility with a large mixed gymnasium, soccer, cricket, rockclimbing, tennis, netball, volleyball and functions centre providing a range of programs to cater for a range of health needs within the community.
- The applicant wishes to provide further programs suited to women's health issues particularly dealing with osteoporosis, exercise and pregnancy, late on-set of

diabetes and breast cancer, all in an area exclusively for women so as they feel safe and comfortable in a non-intimidating environment.

- Programs dealing with these issues can be provided in a mixed gender environment, however it is almost impossible to effectively encourage and motivate women around men who are exercising. Women may feel intimidated by men who are particularly big or strong or who are engaging in exercise involving displays of great physical strength such as the lifting of heavy weights. This environment may be particularly intimidating to women who have in the past experienced sexual assault, abuse or violence from men.
- The Altona area, where the gym is situated, is largely multicultural with a large portion of the local community being of Muslim or Jewish culture, which prohibit women from exercising around or even associating with men.
- Other women's health issues have arisen which has led to the need to provide a separate gym area for women such as: serious eating disorders such as bulimia, weight loss, incontinence, and body image and self-esteem issues. Women prefer these issues to be discussed in an open forum within an area containing only female trainers, medical staff and clientele. Exercises to deal with such issues can also often be embarrassing within the company of men.
- Male's health issues are very different as opposed to females. The type of equipment used and the general acceptance and its appropriateness are much more accepted by men and easier to instruct and teach than women. Strength training equipment is also often too heavy and impractical for the female body.
- Providing a women's only gym area would cater for the issues raised and faced only by women, providing a sanctuary for women of all cultures, body shapes and backgrounds in a safe and comfortable environment, offering equipment suited to the female body as well as female instructors and medical staff.
- The gym, as well as providing an area exclusively for women, will continue to provide other areas where women and men can exercise together.

The Tribunal grants an exemption from the operation of Sections 13, 42, 65, 100 and 195 of the **Equal Opportunity Act 1995**, to enable the applicant to open an exclusive ladies only area in the leisure centre's gymnasium and have it staffed by female personnel.

This exemption is to remain in force from the day on which notice of the exemption is published in the Government Gazette until 6 October 2002.

Ultra Heat Treated Milk with 5% Ultra Filtered permeate added is UHT milk as defined above with 5% (by volume) of ultra filtered permeate added.

Flavoured milk is milk to which flavouring, as defined in the Food Standards Code, has been added so as to alter the odour or taste of the milk to an appreciable extent.

Concentrated skim milk and concentrated whole milk used in the manufacture of market milk is market milk.

Milk used in the production of "Vita Plus" is market milk for the purposes of the above Act.

- Standardised raw milk for processing as Ultra heat treated milk with 5% ultra

- filtered permeate added for sale in Australia will be 39.13 cents per litre.
- j) Standardised raw milk for processing as sterilised milk for sale by export will be 21.06 cents per litre.
- k) Standardised raw milk for processing as daily pasteurised organic and bio-dynamic milk for sale in Victoria will be 56.70 cents per litre.
- Standardised raw milk for processing as daily pasteurised organic and bio-dynamic milk for sale in Australia but outside Victoria will be 55.71 cents per litre.
- m) Standardised raw milk for processing as organic milk for sale by export will be 24.49 cents per litre.
- Standardised raw milk for processing as concentrated skim milk for use to adjust the solids content in market milk for sale in Victoria will be 31.34 cents per litre.

To ensure that material received can be reproduced, and that errors are minimised, the following guidelines are to be observed when submitting material by fax.

Fax resolution:

Material sent by fax should be transmitted using Fine Resolution (200 dots per inch by 200 dpi).

Font size:

Use 12 point (10 pitch) or larger.

Font Style:

Clear plain font styles, such as Helvetica, should be used.

Graphics:

Line drawings should be transmitted as large as possible to ensure clarity. Drawings up to A4 size sent by fax using Fine Resolution provide a good quality for reproduction.

Avoid:

Italics, underlining and full justification.

Ensure document is square when sending as documents that are sent skewed are difficult to read and process.
