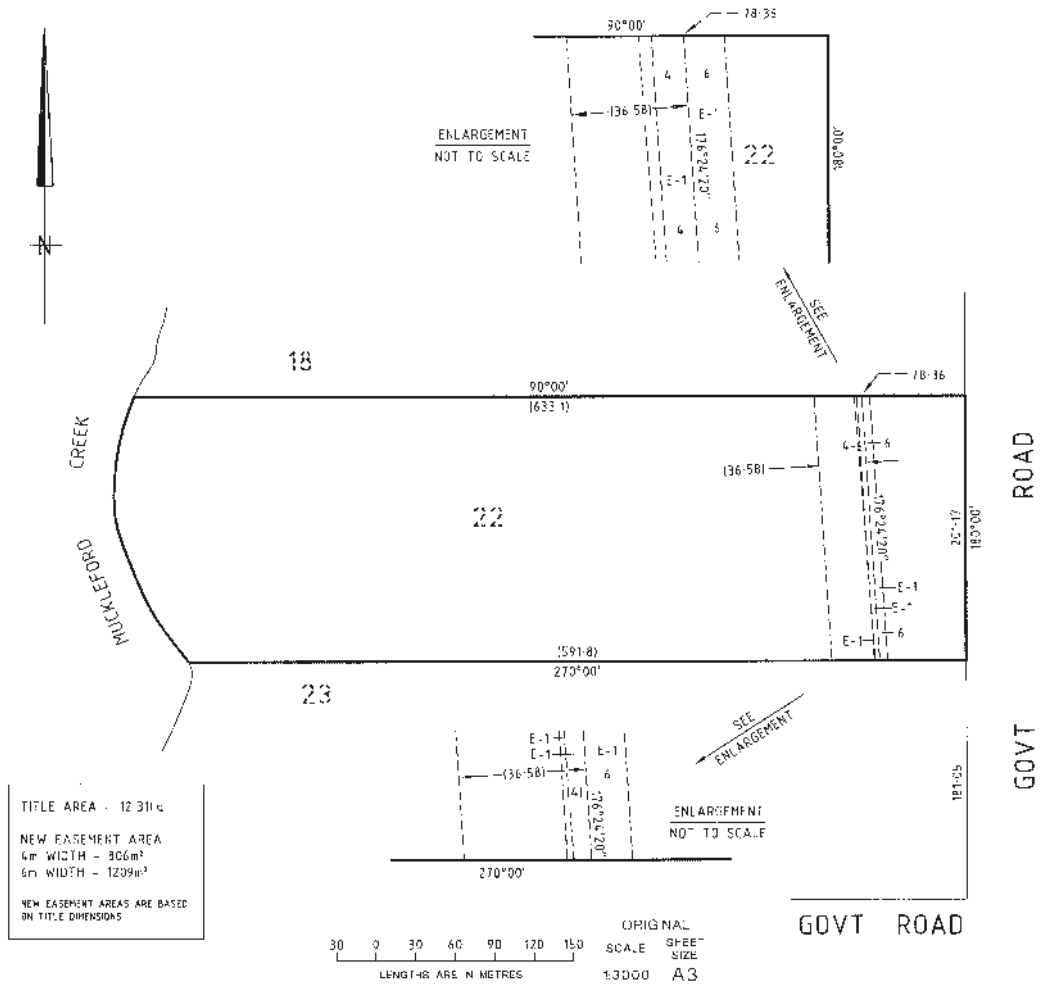


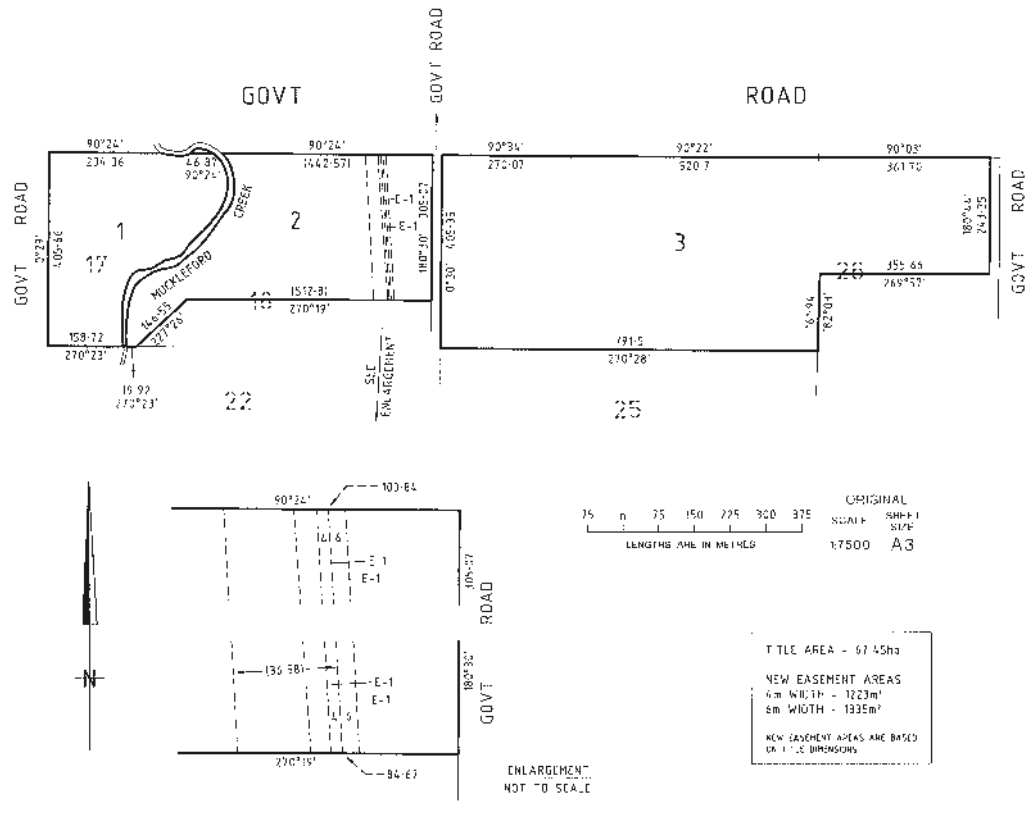
TITLE AREA - 558670
