Notice of Approval of Amendment
Amendment C37

The Minister for Planning has approved Amendment C37 to the Glenelg Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment modifies the schedules to the Development Plan Overlay Nos. 1–5 and 6 allowing the council to consider planning permit applications before a Development Plan is approved until 31 December 2008.

The land affected is generally bound by to the south by the Cranbourne Railway Line, to the east by Cheltenham Road and Thomas Street, to the north by Walker Street and George Street and to the west by the Grenda Bus Depot, Dandenong. Additional affected land is generally located on the north side of George Street, the east side of Thomas Street, the west side of Lonsdale Street and the south side of Walker Street.

The Minister for Planning has approved Amendment C95 to the Greater Dandenong Planning Scheme.

The Amendment comes into operation on the date this notice is published in the Government Gazette.

The Amendment applies a Public Acquisition Overlay to land in Central Dandenong and creates a new entry in the Schedule to the Public Acquisition Overlay that identifies the Victorian Urban Development Authority (VicUrban) as the acquisition authority for the purpose of the Revitalising Central Dandenong Project.
